## ADMISSION AND EQUIVALENCE

INTERVIEWS AND VIDEOCONFERENCES

The admission and equivalence committees allow students to join ESAPB throughout the course of the curriculum.

Candidates are invited to an online interview with a jury made up of the school's director and teaching staff, during which they present their portfolio.

The admission level is confirmed by the committee after examining the applications through an interview by videoconference and upon submission of a portfolio of personal work.

#### ADMISSIONS COMMITTEE

The admission committee is for students who have begun their studies at other art schools approved by the French Ministry of Culture.

#### EQUIVALENCE COMMITTEE

The equivalence committee applies to students who have completed a university course in the plastic or applied arts (passerelle Éducation Nationale/Ministère de la Culture) or who have completed one or more years of artistic studies in another higher education institution not accredited by the Ministry of Culture.

#### REQUIREMENTS FOR FINAL ADMISSION

Final admission is subject to the committee's approval, provided that the necessary credits have been obtained and/or the candidate has passed the examinations. Only candidates who have obtained the necessary credits and diplomas for the level of admission will be able to enrol permanently at the School.

Students who are in the process of obtaining credits may take part in the commissions; enrolment becomes permanent upon presentation of the proof of credits.

To be eligible for admission to Year 2, 3 and 5, applicants must have completed 60, 120 and 240 European credits respectively.

Enrolment in Year 4 is subject to obtaining the Diplôme national d'art. In the case of an equivalence commission, admission to semester 7 is subject to completion of 180 European credits.

#### NON-FRENCH SPEAKING CANDIDATES

Non-French-speaking applicants must provide proof of a level of proficiency in the French language: TCF - Test de Connaissance de la langue Française NIVEAU B2 less than 2 years old.

The TCF can be taken abroad at authorised institutions such as French embassies and universities, or in France at centres approved by the CIEP (Centre International d'Etudes Pédagogiques).

- a detailed letter of intent, setting out the study project and in particular the decision to join ESAPB (1 page) ;
- a Curriculum Vitae giving details of the applicant's academic record ;
- a copy of the applicant's academic record: copy of diplomas obtained (BAC, BTS, Licence), transcript of baccalauréat

grades, certificate of enrolment for the current year and transcripts of grades or credits for each year of study.

> For candidates wishing to enrol at ESAPB in year 4 :

- an international mobility project (1 page) detailing the compulsory mobility choice in semester 8 among :
  - an academic exchange semester in a higher education establishment abroad ;
  - a long-term internship abroad (minimum 4 months) ;
  - a cross-border mobility, combining academic exchanges and short internships in the New Aquitaine - Euskadi - Navarre Euroregion.

> For foreign applicants :

- TCF level B2 (for non-French-speaking applicants) ;
- translations of diplomas obtained and the compulsory certificate of authentication of diplomas obtained (credentials reports) ;
- certificate of enrolment from the last school attended;
- residence permit for applicants for French residents.
- certificate of comparability issued by the Enic Naric France centre
